A question was raised about the installation of a bell at the front door. The Town Clerk advised that the order had been placed with a local electrician and it would be installed at the same time as other electrical work was being undertaken.

**Min 09** - Councillor Poole advised that it had proved difficult to secure a scroll within the timescale and proposed that the agreed finance be placed towards a suitable framed photograph of the town. Councillor Penfold seconded the proposal and it was RESOLVED that a suitable photograph and frame would replace a scroll.

### 13. FLOOD WARDEN SCHEME FOR MALMESBURY

Councillor Poole presented a report previously provided by Councillor Gundry on the subject of a flood warden scheme for Malmesbury. After considerable debate it was proposed by Councillor Poole, seconded by Councillor Budgen and RESOLVED that the Town Council establishes an official scheme of Flood Wardens as stated in the report.

It was proposed by Councillor Poole, seconded by Councillor Penfold and RESOLVED that the Memorandum of Understanding attached to the report be accepted by the Town Council.

It was proposed by Councillor Poole, seconded by Councillor Kettlety and RESOLVED that the scheme be initiated as soon as possible.
