Parking at the junction of Olivers Lane and High Street. **J Whittleton** to inform the Police Sergeant and Wiltshire Council Enforcement about the matter.

Roundmead. **J Whittleton** to report the response of Wiltshire Council when received.

6. TREE WARDEN

The Tree Warden was in attendance to give the Committee an overview of her work.

The Committee noted:

• That the position is part of a national scheme. There are some 25,000 tree wardens nationwide;

- That the majority of the Wardens work is led by the people of Malmesbury, in that she responds to enquiries that come into Wiltshire Council:
- The Rowan tree in the Horse Fair. The Tree Warden advised that the tree should not be replaced as it was directly on a drain. The Committee noted that the area is now being looked after as a garden;
- Most applications to remove trees are because of their proximity to drains:
- The Tree Warden has worked with MRVT, answering questions on planting at Conygre Mead;
- The Committee noted that it is unlawful to fell a tree with a known bird nesting;
- The Warden attends the national tree warden meeting, which is useful for networking; and
- That the Council could give thought to replacing some of the Poplars in St Aldhelm's Mead.
