## FC/24/73 To receive update from Cllr Grant, Wiltshire Councillor for Malmesbury

Cllr Grant reported;

- The Area Board AGM takes place in June and election for Chair will take place.
- 2 arrests had been made following engagement with Cllr Grant by concerned residents at Kings Wall and illegal activities.
- The LYN will meet this week and the request for bump track/skate park is on the agenda.
- The Town Businesses meeting will be underway shortly, likely after the late Bank Holiday.
- A meeting will be convened with Persimmon, Tetbury Hill Gardens Residents, Fruitful Malmesbury & the School to discuss planning applications at that area.

# FC/24/74 To consider a vote of no confidence in Wiltshire Council's planning function following (Taking account of any information made available to Malmesbury Town Council on these matters since our last Full Council meeting on 7th May 2024)

(i) The non determination of Planning Application at PL/2023/03637: Land parcel off the A429, located (north) of Waitrose, Malmesbury, SN16 9NZ, Following discussion, and it was noted that Cllr Grant will abstain from voting as he sits on the Northern Area Planning Committee, a majority vote carried in favour of a vote of no confidence in Wiltshire Council's planning function.

# (ii) The absence of action to seek and share legal advice or to appeal the Inspector decision to allow housing at PL/2021/09852 - Land East of Waitrose,

Following discussion, and it was noted that Cllr Grant will abstain from voting as he sits on the Northern Area Planning Committee, a majority vote carried in favour of a vote of no confidence in Wiltshire Council's planning function.

Cllrs Crawford-Price, Grant & Ritchie will prepare a statement for residents as to how and why the decisions at (i) & (ii) were reached.

The Town Clerk was asked to invite Cllrs Boterill & Thomas to a future meeting of the Council.
