War Memorial Working Group

Abbey Mill Bridge

Following a reported incident where a child had to be restrained from falling through the gap and into the river below, the Dep Town Clerk and Town Clerk contacted Bridges Dept and Engineer S Hind as a matter of urgency and we await their response. It was agreed that Chair J Slade will write to the highways portfolio holder at Wiltshire Council to request that a site visit to view the state of disrepair and for temporary safety measures to be erected.

Market Cross

Gullies have not been cleared. Traffic cones had been placed to keep the area clear for the gullies vehicle but the cones had been moved and therefore access was not available. Highways Department have advised traffic management will need to arranged and we will advised when this will take place. Dep Town Clerk is contacting the specialist stonemasons to check on their availability and quote and will be applying for Scheduled Monument Permission.

Wheeler Way

Currently awaiting information on underground drainage to this area, from Strategic Property at Wiltshire Council.

Footpaths

Dep Town Clerk will research land ownership to the footpath from opposite Spice Merchant to Bowls Club.

Bins/Recycling

Survey of the condition of Town Council bins will be underway shortly, undertaken by grounds staff.
