### THE COUNTY OF WILTSHIRE (MALMESBURY AND MALMESBURY WITHOUT) (PROHIBITION AND RESTRICTION OF WAITING, TAXI RANK CLEARWAYS AND ON STREET PARKING) CONSOLIDATION ORDER 2017 (AMENDMENT NO.8) ORDER 2026

The Council of the County of Wiltshire in exercise of its powers under Sections 1, 2, 4, 32, 35, 53 and Part IV of Schedule 9 of the Road Traffic Regulation Act 1984 (hereinafter referred to as “the Act of 1984”) as amended and the Traffic Management Act 2004 (hereinafter referred to as “the Act of 2004”) as amended and of all other enabling powers and after consultation with the Chief Officer of Police in accordance with Part III of Schedule 9 to the Act of 1984 hereby makes the following Order.

1. The County of Wiltshire (Malmesbury and Malmesbury Without) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2017 shall be amended by the revocation of the Map Schedule specified in the First Schedule to this Order and the insertion of the Map Schedule specified in the Second Schedule to this Order.
2. The effect of the Order will be as follows:
  - a) To remove **No Waiting Monday to Saturday 8am – 6pm** on the following lengths of roads:
    - Foundry Road** – both sides – from its junction with Horsefair to a point 5 metres north of the southern building edge of property No.40 Horsefair
    - Horsefair** – east side – from its junction with Foundry Road to a point 15 metres south of the southern building edge of property No.40 Horsefair
    - Horsefair** – north side – from its junction with the western side of Foundry Road to its junction with the northern side of Burnham Road
  - b) To introduce **No Waiting at any time** on the following lengths of road:
    - Foundry Road** – both sides – from its junction with Horsefair to a point in line with the southern building edge of property No.40 Horsefair
    - Horsefair** – east side – from its junction with Foundry Road to a point 15 metres south of the southern building edge of property No.40 Horsefair
    - Horsefair** – north side – from its junction with the western side of Foundry Road to its junction with the northern side of Burnham Road
3. This Order shall come into operation on xxxxxxxx 2026 and may be cited as The County of Wiltshire (Malmesbury and Malmesbury Without) (Prohibition and Restriction of Waiting, Taxi Rank Clearways and On Street Parking) Consolidation Order 2017 (Amendment No.8) Order 2026.
