NOTICE IS HEREBY GIVEN THAT Wiltshire Council proposes to make the above Order under the Road Traffic Regulation Act 1984 and the Traffic Management Act 2004 the effect of which will be to amend the restrictions in the **Malmesbury and Malmesbury Without** Consolidation Order 2017, to revoke Map Schedule No. AX41 dated 21st August 2017 and replace it with the insertion of revised Map Schedule No. AX41 the effect of which will as follows:

- a) To remove No Waiting Monday to Saturday 8am 6pmon the following lengths of roads: Foundry Road, Malmesbury – both sides – from its junction with Horsefair to a point 5 metres north of the southern building edge of property No.40 Horsefair Horsefair, Malmesbury – east side – from its junction with Foundry Road to a point 15 metres south of the southern building edge of property No.40 Horsefair Horsefair, Malmesbury – north side – from its junction with the western side of Foundry Road to its junction with the northern side of Burnham Road
- b) To introduce No Waiting at any time on the following lengths of road: Foundry Road – both sides – from its junction with Horsefair to a point in line with the southern building edge of property No.40 Horsefair Horsefair, Malmesbury – east side – from its junction with Foundry Road to a point 15 metres south of the southern building edge of property No.40 Horsefair Horsefair, Malmesbury – north side – from its junction with the western side of Foundry Road to its junction with the northern side of Burnham Road
